**Proceedings (In Chambers):**                      **Order CONSOLIDATING Case with *City of Hallandale Beach Police Officers and Firefighters Personnel Retirement Trust v. FIGS, Inc. et al.* (No. 2:22-cv-08912-ODW (KSx)) and GRANTING Stipulation**

Pending before the Court are several motions to consolidate this case with *City of Hallandale Beach Police Officers and Firefighters Personnel Retirement Trust v. FIGS, Inc. et al.*, No. 2:22-cv-08912-ODW (KSx). (Mots. (collectively, “Motions”), ECF Nos. 17, 26, 30, 34, 35, 36.) The movants also seek appointment as lead plaintiff and approval of their selection of counsel. (*Id.*) The Court has reviewed the Motions. Pursuant to Federal Rule of Civil Procedure 42, and because these two cases are PSLRA cases that arise from common facts, the Court hereby **GRANTS IN PART** the Motions and **CONSOLIDATES** this case with *City of Hallandale*, No. 2:22-cv-08912-ODW (KSx), for all purposes. This case (*Ryan*) shall be the lead case. All further filings shall be filed in this case (*Ryan*) only.

Also pending before the Court is a Joint Stipulation Appointing Dr. Ronald Hoch and Public Pension Plans as Lead Plaintiff and Approving Levi & Korsinsky, LLP and Robbins Geller Rudman & Dowd LLP as Lead Counsel (“Joint Stipulation”). (Joint Stip., ECF No. 58.) Having reviewed the Joint Stipulation and finding good cause, the Court **GRANTS** the Joint Stipulation, as follows:

1. Pursuant to 15 U.S.C. §78u-4(a)(3)(B) and 15 U.S.C. §77z-1(a)(3)(B), Dr. Hoch and the City of Pensacola Police Officers' Retirement Plan, the City of Warren Police and Fire Retirement System, the Kissimmee Utility Authority Employees' Retirement Plan, and the Pompano Beach Police & Firefighters' Retirement System are appointed Lead Plaintiff for the class; and
2. Pursuant to 15 U.S.C. §78u-4(a)(3)(B)(v) and 15 U.S.C. §77z-1(a)(3)(B)(v), Lead Plaintiff's selections of Levi & Korsinsky and Robbins Geller as Lead Counsel are approved.

The entry of this order resolves the pending Motions at ECF Nos. 17, 26, 30, 34, 35, and 36.
